### **DOMESTIC WASTEWATER**

The following summary is provided for this pending water quality permit application being reviewed by the Texas Commission on Environmental Quality as required by 30 Texas Administrative Code Chapter 39. The information provided in this summary may change during the technical review of the application and are not federal enforceable representations of the permit application.

Camp for All Foundation (CN600708788) operates Camp for All Foundation Wastewater Treatment Plant (RN102080660). a non-profit camp for adults and children with challenging illnesses or special needs and their families. The facility is located approximately 375 feet southeast of the intersection of Rehburg Road and Oliver Earl Lane, 4.15 miles Northeast of the City of Burton, in the Northwest portion of Washington County, in City of Burton, Washington County, Texas 77835.

This application is for the renewal to discharge at an annual average flow of 0.045 Million Gallons Daily of treated domestic wastewater via Outfall 001.

Discharges from the facility are expected to contain Biochemical Oxygen Deman (5-days), Total Suspended Solids, and E. coli. Additional. Domestic wastewater is treated by *bar screen pretreatment*, activated sludge, enhanced secondary clarification, chlorination and an aerobic digester.

# NOTICE OF RECEIPT OF APPLICATION AND INTENT TO OBTAIN WATER QUALITY PERMIT RENEWAL.

### PERMIT NO. WQ0013838001

APPLICATION. Camp For All Foundation, 3701 Kirby Drive, Suite 570, Houston, Texas 77098, has applied to the Texas Commission on Environmental Quality (TCEQ) to renew Texas Pollutant Discharge Elimination System (TPDES) Permit No. WQ0013838001 (EPA I.D. No. TX0114413) to authorize the discharge of treated wastewater at a volume not to exceed a daily average flow of 45,000 gallons per day. The domestic wastewater treatment facility is located at located approximately 375 feet southeast of the intersection of Oliver Earl Lane and Rehburg Road, in Washington County, Texas 77835. The discharge route is from the plant site to an unnamed tributary; thence to Old Rocky Creek; thence to Jerdelle Creek; thence to Somerville Lake. TCEQ received this application on April 5, 2024. The permit application will be available for viewing and copying at Nancy Carol Roberts Memorial Library, 100 Martin Luther King Jr. Parkway, Brenham, Texas prior to the date this notice is published in the newspaper. ADDITIONAL NOTICE. TCEQ's Executive Director has determined the application is administratively complete and will conduct a technical review of the application. After technical review of the application is complete, the Executive Director may prepare a draft permit and will issue a preliminary decision on the application. Notice of the Application and Preliminary Decision will be published and mailed to those who are on the countywide mailing list and to those who are on the mailing list for this application. That notice will contain the deadline for submitting public comments.

**PUBLIC COMMENT / PUBLIC MEETING. You may submit public comments or request a public meeting on this application.** The purpose of a public meeting is to provide the opportunity to submit comments or to ask questions about the application. TCEQ will hold a public meeting if the Executive Director determines that there is a significant degree of public interest in the application or if requested by a local legislator. A public meeting is not a contested case hearing.

**OPPORTUNITY FOR A CONTESTED CASE HEARING.** After the deadline for submitting public comments, the Executive Director will consider all timely comments and prepare a response to all relevant and material, or significant public comments. **Unless the application** 

is directly referred for a contested case hearing, the response to comments, and the Executive Director's decision on the application, will be mailed to everyone who submitted public comments and to those persons who are on the mailing list for this application. If comments are received, the mailing will also provide instructions for requesting reconsideration of the Executive Director's decision and for requesting a contested case hearing. A contested case hearing is a legal proceeding similar to a civil trial in state district court.

TO REQUEST A CONTESTED CASE HEARING, YOU MUST INCLUDE THE FOLLOWING ITEMS IN YOUR REQUEST: your name, address, phone number; applicant's name and proposed permit number; the location and distance of your property/activities relative to the proposed facility; a specific description of how you would be adversely affected by the facility in a way not common to the general public; a list of all disputed issues of fact that you submit during the comment period and, the statement "[I/we] request a contested case hearing." If the request for contested case hearing is filed on behalf of a group or association, the request must designate the group's representative for receiving future correspondence; identify by name and physical address an individual member of the group who would be adversely affected by the proposed facility or activity; provide the information discussed above regarding the affected member's location and distance from the facility or activity; explain how and why the member would be affected; and explain how the interests the group seeks to protect are relevant to the group's purpose.

Following the close of all applicable comment and request periods, the Executive Director will forward the application and any requests for reconsideration or for a contested case hearing to the TCEQ Commissioners for their consideration at a scheduled Commission meeting.

The Commission may only grant a request for a contested case hearing on issues the requestor submitted in their timely comments that were not subsequently withdrawn. If a hearing is granted, the subject of a hearing will be limited to disputed issues of fact or mixed questions of fact and law relating to relevant and material water quality concerns submitted during the comment period.

TCEQ may act on an application to renew a permit for discharge of wastewater without providing an opportunity for a contested case hearing if certain criteria are met.]

## NOTICE OF APPLICATION AND PRELIMINARY DECISION FOR TPDES PERMIT FOR INDUSTRIAL WASTEWATER

#### MINOR AMENDMENT

### **PERMIT NO. WQ0001012000**

**APPLICATION AND PRELIMINARY DECISION.** Campbell Soup Supply Company L.L.C., P.O. Box 9016, Paris, Texas 75461, which operates Campbell Soup Paris Plant, a canning facility that produces various soups and other specialty foods, and manufactures steel containers, has applied to the Texas Commission on Environmental Quality (TCEQ) for a minor amendment to Texas Pollutant Discharge Elimination System (TPDES) Permit No. WQ0001012000 to move the monitoring requirements and effluent limitations for oil and grease from internal Outfall 101 to Outfall 001 and to remove Other Requirement No. 13 (self-imposed operator certification requirements). The draft permit authorizes the discharge of treated process wastewater, utility wastewater, and stormwater via Outfall 001 at a daily average flow rate not to exceed 10,000,000 gallons per day. The TCEQ received this application on April 6, 2023.

The facility is located at 500 North Loop 286, which is approximately 1/4 mile west of the intersection of United States Loop Highway 286 and United States Highway 271, in the northern portion of the City of Paris, Lamar County, Texas 75460. The effluent is discharged to unnamed tributary numbers 1, 2, and 3; thence to Smith Creek; thence to Pine Creek; thence to Red River Below Lake Texoma in Segment No. 0202 of the Red River Basin. The unclassified receiving water uses are minimal aquatic life use for unnamed tributary Nos. 1, 2, and 3; minimal aquatic life use for Smith Creek; and intermediate aquatic life use for Pine Creek. The designated uses for Segment No. 0202 are primary contact recreation, public water supply, and high aquatic life use.

The TCEQ Executive Director has completed the technical review of the application and prepared a draft permit. The draft permit, if approved, would establish the conditions under which the facility must operate. The Executive Director has made a preliminary decision that this permit, if issued, meets all statutory and regulatory requirements.

You may submit public comments or request a public meeting about this application.** The purpose of a public meeting is to provide the opportunity to submit written or oral comment or to ask questions about the application.
