NOTICE OF APPLICATION AND PRELIMINARY DECISION FOR WATER QUALITY TPDES PERMIT FOR MUNICIPAL WASTEWATER

MINOR AMENDMENT

PERMIT NO. WQ0013574001

APPLICATION AND PRELIMINARY DECISION. Cayuga Independent School District, P.O. Box 427, Cayuga, Texas 75832, has applied to the Texas Commission on Environmental Quality (TCEQ) for a minor amendment to Texas Pollutant Discharge Elimination System (TPDES) Permit No. WQ0013574001 to authorize a decrease in the discharge of treated domestic wastewater from a daily average flow not to exceed 30,000 gallons per day to a daily average flow not to exceed 9,000 gallons per day. The existing permit authorizes the discharge of treated domestic wastewater at a daily average flow not to exceed 30,000 gallons per day. TCEQ received this application on July 27, 2023.

The facility is located at 17750 North U.S. Highway 287, in Anderson County, Texas 75861. The treated effluent is discharged to an unnamed creek, thence to Saline Branch, thence to Trinity River Above Lake Livingston in Segment No. 0804 of the Trinity River Basin. The unclassified receiving water use is minimal aquatic life use for the unnamed creek. The designated uses for Segment No. 0804 are primary contact recreation and high aquatic life use. The TCEQ Executive Director has completed the technical review of the application and prepared a draft permit. The draft permit, if approved, would establish the conditions under which the facility must operate. The Executive Director has made a preliminary decision that this permit, if issued, meets all statutory and regulatory requirements.

PUBLIC COMMENT / PUBLIC MEETING. You may submit public comments or request a public meeting about this application. The purpose of a public meeting is to provide the opportunity to submit written or oral comment or to ask questions about the application. Generally, the TCEQ will hold a public meeting if the Executive Director determines that there is a significant degree of public interest in the application or if requested by a local legislator. A public meeting is not a contested case hearing.

After the deadline for public comments, the Executive Director will consider the comments and prepare a response to all relevant and material, or significant public comments. **The response to comments will be mailed to everyone who submitted public comments or who requested to be on a mailing list for this application.**

MAILING LIST. If you submit public comments, you will be added to the mailing list for this specific application to receive future public notices mailed by the Office of the Chief Clerk. In addition, you may request to be placed on: (1) the permanent mailing list for a specific applicant name and permit number; and/or (2) the mailing list for a specific county. If you wish to be placed on the permanent and/or the county mailing list, clearly specify which list(s) and send your request to TCEQ Office of the Chief Clerk at the address below.
