## NOTICE OF APPLICATION AND PRELIMINARY DECISION FOR TPDES PERMIT FOR INDUSTRIAL WASTEWATER

## **AMENDMENT**

## Permit No. WQ0005364000

APPLICATION AND PRELIMINARY DECISION. Freeport LNG Development, L.P., 333 Clay Street, Suite 5050, Houston, Texas 77002, which operates the Freeport LNG Liquefaction Plant, a liquid natural gas terminal and liquefaction facility, has applied to the Texas Commission on Environmental Quality (TCEQ) for a minor amendment to their existing Texas Railroad Commission (RRC) and National Pollutant Discharge Elimination System (NPDES) permits and combining these two permits into the first time issuance of Texas Pollutant Discharge Elimination System (TPDES) Permit No. WQ0005364000 to change Whole Effluent Testing (WET) sampling requirements from composite samples to grab samples. The draft permit authorizes the discharge of air vaporization wastewater at a daily average flow not to exceed 757,500 gallons per day via Outfall 001; stormwater on an intermittent and flow-variable basis via Outfalls 002, 003, and 004; stormwater, compressor condensate, and utility wastewater on an intermittent and flow-variable basis via Outfalls 005, 007, 008, and 009; and stormwater and vehicle washwater on an intermittent and flow-variable basis via Outfall 006. The TCEQ received this application on January 2, 2023.

The facility is located at 1500 Lamar Street, in the City of Quintana, Brazoria County, Texas 77541. This link to an electronic map of the site or facility's general location is provided as a public courtesy and is not part of the application or notice. The effluent is discharged via Outfalls 001, 003, and 004 to created wetlands, thence to West Velasco Ditch, thence to the Gulf Intracoastal Waterway; via Outfalls 002, 005, 007, 008, and 009 to the Gulf Intracoastal Waterway; and via Outfall 006 to the West Velasco Ditch, thence to the Gulf Intracoastal Waterway; thence all to Segment No. 2501 of the Gulf of Mexico. The unclassified receiving water uses are high aquatic life use for the created wetlands, the Intercoastal Waterway, and the West Velasco Ditch. The designated uses for Segment No. 2501 are primary contact recreation, exceptional aquatic life use, and oyster waters.

The TCEQ Executive Director reviewed this action for consistency with the Texas Coastal Management Program (CMP) goals and policies in accordance with the regulations of the General Land Office and has determined that the action is consistent with the applicable CMP goals and policies.

The TCEQ Executive Director has completed the technical review of the application and prepared a draft permit. The draft permit, if approved, would establish the conditions under which the facility must operate. The Executive Director has made a preliminary decision that this permit, if issued, meets all statutory and regulatory requirements. The permit application, Executive Director's preliminary decision, and draft permit are available for viewing and copying at the Freeport Branch Library, 410 Brazosport Boulevard, Freeport, Texas.

**PUBLIC COMMENT / PUBLIC MEETING.** You may submit public comments or request a public meeting about this application. The purpose of a public meeting is to provide the opportunity to submit written or oral comment or to ask questions about the application. Generally, the TCEQ will hold a public meeting if the Executive Director determines that there is a significant degree of public interest in the application or if requested by a local legislator. A public meeting is not a contested case hearing.

OPPORTUNITY FOR A CONTESTED CASE HEARING. After the deadline for public comments, the Executive Director will consider the comments and prepare a response to all relevant and material, or significant public comments. The response to comments, along with the Executive Director's decision on the application, will be mailed to everyone who submitted public comments or who requested to be on a mailing list for this application. If comments are received, the mailing will also provide instructions for requesting a contested case hearing or reconsideration of the Executive Director's decision. A contested case hearing is a legal proceeding similar to a civil trial in a state district court.

TO REQUEST A CONTESTED CASE HEARING, YOU MUST INCLUDE THE FOLLOWING ITEMS IN YOUR REQUEST: your name, address, phone number; applicant's name and proposed permit number; the location and distance of your property/activities relative to the proposed facility; a specific description of how you would be adversely affected by the facility in a way not common to the general public; a list of all disputed issues of fact that you submit during the comment period; and the statement "[I/we] request a contested case hearing." If the request for contested case hearing is filed on behalf of a group or association, the request must designate the group's representative for receiving future correspondence; identify by name and physical address an individual member of the group who would be adversely affected by the proposed facility or activity; provide the information discussed above regarding the affected member's location and distance from the facility or activity; explain how and why the member would be affected; and explain how the interests the group seeks to protect are relevant to the group's purpose.

Following the close of all applicable comment and request periods, the Executive Director will forward the application and any requests for reconsideration or for a contested case hearing to the TCEQ Commissioners for their consideration at a scheduled Commission meeting.

The Commission may only grant a request for a contested case hearing on issues the requestor submitted in their timely comments that were not subsequently withdrawn. If a hearing is granted, the subject of a hearing will be limited to disputed issues of fact or mixed questions of fact and law relating to relevant and material water quality concerns submitted during the comment period. TCEQ may act on an application to renew a permit for discharge of wastewater without providing an opportunity for a contested case hearing if certain criteria are met.

**EXECUTIVE DIRECTOR ACTION.** The Executive Director may issue final approval of the application unless a timely contested case hearing request or a timely request for reconsideration is filed. If a timely hearing request or request for reconsideration is filed, the Executive Director will not issue final approval of the permit and will forward the application and requests to the TCEQ Commissioners for their consideration at a scheduled Commission meeting.

**MAILING LIST.** If you submit public comments, a request for a contested case hearing or a reconsideration of the Executive Director's decision, you will be added to the mailing list for this specific application to receive future public notices mailed by the Office of the Chief Clerk. In addition, you may request to be added to: (1) the permanent list for a specific applicant name and permit number; and (2) the mailing list for a specific county. If you wish to be placed on the permanent and the county mailing list, clearly specify which list(s) and send your request to TCEQ Office of the Chief Clerk at the address below.
