Hudson Products Corporation whose mailing address is 9660 Grunwald Road Beasley, Texas 77417 treats and discharges wastes from Hudson Products Corporation Wastewater Treatment Facility, an industrial products manufacturing plant that produces air cooled heat exchangers and fiberglass fan blades (SIC 3443 and 3564) located at 9660 Grunwald Road, near the City of Beasley, in Fort Bend County, Texas 77417 via Outfall 001 to Turkey Creek, thence to San Bernard River Above Tidal in Segment No. 1302 of the Brazos-Colorado Coastal Basin.

Discharges from the facility contain Chemical Oxygen Demand, Total Suspended Solids, Oil and Grease, Total Aluminum, and pH. The facility discharges process wastewater (Average: 0.36 MGD, Maximum: 6.5 MGD), utility wastewater, stormwater runoff, and previously monitored effluent from Outfall 101 that is treated by a Package Aeration Wastewater Treatment Plant, operated on site.
