NOTICE OF APPLICATION AND PRELIMINARY DECISION FOR WATER QUALITY TPDES PERMIT FOR MUNICIPAL WASTEWATER

MINOR AMENDMENT

PERMIT NO. WQ0014080001

APPLICATION AND PRELIMINARY DECISION. The Texas Commission on Environmental Quality (TCEQ) has initiated a minor amendment of the Texas Pollutant Discharge Elimination System (TPDES) Permit No. WQ0014080001 issued to Southern Utilities Company, 218 North Broadway Avenue, Tyler, Texas 75702, to authorize the addition of pH monitoring frequency. The existing permit authorizes the discharge of treated filter backwash effluent from a water treatment plant at a daily average flow not to exceed 6,000 gallons per day.

The facility is located at 19246 County Road 178, in Smith County, Texas 75762. The treated effluent is discharged to a roadside ditch, thence to an unnamed tributary, thence to Saline Creek, thence to Lake Palestine in Segment No. 0605 of the Neches River Basin. The unclassified receiving water uses are minimal aquatic life use for the roadside ditch and the unnamed tributary, and high aquatic life use for Saline Creek. The designated uses for Segment No. 0605 are primary contact recreation, public water supply, and high aquatic life use. The TCEQ Executive Director has completed the technical review of the application and prepared a draft permit. The draft permit, if approved, would establish the conditions under which the facility must operate. The Executive Director has made a preliminary decision that this permit, if issued, meets all statutory and regulatory requirements.

PUBLIC COMMENT / PUBLIC MEETING. You may submit public comments or request a public meeting about this application. The purpose of a public meeting is to provide the opportunity to submit written or oral comment or to ask questions about the application. Generally, the TCEQ will hold a public meeting if the Executive Director determines that there is a significant degree of public interest in the application or if requested by a local legislator. A public meeting is not a contested case hearing.

After the deadline for public comments, the Executive Director will consider the comments and prepare a response to all relevant and material, or significant public comments. **The response to comments will be mailed to everyone who submitted public comments or who requested to be on a mailing list for this application.**

MAILING LIST. If you submit public comments, you will be added to the mailing list for this specific application to receive future public notices mailed by the Office of the Chief Clerk. In addition, you may request to be placed on: (1) the permanent mailing list for a specific applicant name and permit number; and/or (2) the mailing list for a specific county. If you wish to be placed on the permanent and/or the county mailing list, clearly specify which list(s) and send your request to TCEQ Office of the Chief Clerk at the address below.
