## NOTICE OF APPLICATION AND PRELIMINARY DECISION (NAPD) FOR WATER QUALITY TPDES PERMIT FOR INDUSTRIAL WASTEWATER

## **MAJOR AMENDMENT**

## Permit No. WQ0005329000

APPLICATION AND PRELIMINARY DECISION. Targa Midstream Services LLC, 811 Louisiana Street, Suite 2100, Houston, Texas 77002, which operates Mont Belvieu Complex, a natural gas processing facility, has applied to the Texas Commission on Environmental Quality (TCEO) for a major amendment without renewal to their existing Texas Railroad Commission (RRC) and National Pollutant Discharge Elimination System (NPDES) permits and combining these two permits into the first-time issuance of Texas Pollutant Discharge Elimination System (TPDES) Permit No. WQ0005329000 to add boiler steam condensate and hydrostatic test water to the authorized waste streams at Outfall 001; remove Whole Effluent Toxicity (WET) limits at Outfall 002; and remove WET testing requirements at Outfalls 001 and 004. The proposed draft permit authorizes the discharge of stormwater, fire testing water, boiler steam condensate, hydrostatic test water, and allowable non-stormwater at a daily average flow not to exceed 293,000 gallons per day during dry-weather discharge via Outfall 001; the discharge of blowdown waters and water treatment wastes at a continuous rate via Outfall 002; the discharge of stormwater and allowable non-stormwater at an intermittent and flow-variable rate via Outfalls 003, 005, and 006; and the discharge of blowdown waters, water treatment wastes, and blowdown waters at a continuous rate via Outfall 004. The TCEQ received this application on August 17, 2022.

The facility is located at 10319 North Highway 146, in the City of Mont Belvieu, Chambers County, Texas 77523. The effluent is discharged to various unnamed tributaries via Outfalls 001, 003, 005, and 006, thence to Cedar Bayou Tidal, and via Outfalls 002 and 004 directly to Cedar Bayou Tidal in Segment No. 0901 of the Trinity-San Jacinto Coastal Basin. The unclassified receiving water uses are minimal aquatic life use for the unnamed tributaries. The designated uses for Segment No. 0901 are primary contact recreation and high aquatic life use.

In accordance with 30 Texas Administrative Code §307.5 and the TCEQ implementation procedures (June 2010) for the Texas Surface Water Quality Standards, an antidegradation review of the receiving waters was performed. A Tier 1 antidegradation review has preliminarily determined that existing water quality uses will not be impaired by this permit action. Numerical and narrative criteria to protect existing uses will be maintained. In accordance with 30 Texas Administrative Code §307.5 and TCEQ's *Procedures to Implement the Texas Surface Water Quality Standards* (June 2010), an antidegradation review of the receiving waters was performed. A Tier 1 antidegradation review has preliminarily determined that existing water quality uses will not be impaired by this permit action. Numerical and narrative criteria to protect existing uses will determined that existing water quality uses will not be impaired by this permit action. A Tier 2 review has preliminarily determined that no significant degradation of water quality is expected in Cedar Bayou Tidal, which has been identified as having high aquatic life use. Existing uses will be maintained and protected. The preliminary determination can be reexamined and may be modified if new information is received.

The TCEQ Executive Director reviewed this action for consistency with the Texas Coastal Management Program (CMP) goals and policies in accordance with the regulations of the General Land Office and has determined that the action is consistent with the applicable CMP goals and policies.

The TCEQ Executive Director has completed the technical review of the application and prepared a draft permit. The draft permit, if approved, would establish the conditions under which the facility must operate. The Executive Director has made a preliminary decision that this permit, if issued, meets all statutory and regulatory requirements. The permit application, Executive Director's preliminary decision, and draft permit are available for viewing and copying at Sam and Carmena Goss Memorial Branch Library, 1 John Hall Drive, Mont Belvieu, Texas in Chambers County and at Stratford Branch Library, 509 Stratford Street, Highlands, Texas in Harris County.

**PUBLIC COMMENT / PUBLIC MEETING.** You may submit public comments or request a public meeting about this application. The purpose of a public meeting is to provide the opportunity to submit written or oral comment or to ask questions about the application. Generally, the TCEQ will hold a public meeting if the Executive Director determines that there is a significant degree of public interest in the application or if requested by a local legislator. A public meeting is not a contested case hearing.

**OPPORTUNITY FOR A CONTESTED CASE HEARING.** After the deadline for public comments, the Executive Director will consider the comments and prepare a response to all relevant and material, or significant public comments. **The response to comments, along with the Executive Director's decision on the application, will be mailed to everyone who submitted public comments or who requested to be on a mailing list for this application. If comments are received, the mailing will also provide instructions for requesting a contested case hearing or reconsideration of the Executive Director's decision.** A contested case hearing is a legal proceeding similar to a civil trial in a state district court.

TO REQUEST A CONTESTED CASE HEARING, YOU MUST INCLUDE THE FOLLOWING ITEMS IN YOUR REQUEST: your name, address, phone number; applicant's name and proposed permit number; the location and distance of your property/activities relative to the proposed facility; a specific description of how you would be adversely affected by the facility in a way not common to the general public; a list of all disputed issues of fact that you submit during the comment period; and the statement "[I/we] request a contested case hearing." If the request for contested case hearing is filed on behalf of a group or association, the request must designate the group's representative for receiving future correspondence; identify by name and physical address an individual member of the group who would be adversely affected by the proposed facility or activity; provide the information discussed above regarding the affected member's location and distance from the facility or activity; explain how and why the member would be affected; and explain how the interests the group seeks to protect are relevant to the group's purpose.

Following the close of all applicable comment and request periods, the Executive Director will forward the application and any requests for reconsideration or for a contested case hearing to the TCEQ Commissioners for their consideration at a scheduled Commission meeting.

The Commission may only grant a request for a contested case hearing on issues the requestor submitted in their timely comments that were not subsequently withdrawn. If a hearing is granted, the subject of a hearing will be limited to disputed issues of fact or mixed questions of fact and law relating to relevant and material water quality concerns submitted during the comment period.

**EXECUTIVE DIRECTOR ACTION.** The Executive Director may issue final approval of the application unless a timely contested case hearing request or a timely request for reconsideration is filed. If a timely hearing request or request for reconsideration is filed, the Executive Director will not issue final approval of the permit and will forward the application and requests to the TCEQ Commissioners for their consideration at a scheduled Commission meeting.

**MAILING LIST.** If you submit public comments, a request for a contested case hearing or a reconsideration of the Executive Director's decision, you will be added to the mailing list for this specific application to receive future public notices mailed by the Office of the Chief Clerk. In addition, you may request to be added to: (1) the permanent list for a specific applicant name and permit number; and (2) the mailing list for a specific county. If you wish to be placed on the permanent and the county mailing list, clearly specify which list(s) and send your request to TCEQ Office of the Chief Clerk at the address below.

All written public comments and public meeting requests must be submitted to the Office of the Chief Clerk, MC 105, TCEQ, P.O.
