#### Plain Language Summary

Tidehaven ISD (CN600692842 ) operates Tidehaven JH-HS WWTP RN106942220. a domestic wastewater treatment facility. The facility is located 1700 feet southeast of the intersection of State Highway 25 and FM 1095, in El Maton, Matagorda County, Texas 77440.

This application is to renew the permit to discharge treated wastewater at an average daily flow rate of 20,000 gallons per day.

Discharges from the facility are expected to contain no pollutants.Domestic wastewater is treated by activated sludge treatment plant operated by extended aeration mode. Influent screening followed by flow equalization, followed by aeration, followed by clarification, followed by discharge. Excess sludge is aerobically digested then hauled by truck for further treatment/disposal.

**APPLICATION.** Tidehaven Independent School District, P.O. Box 129, El Maton, Texas 77440, has applied to the Texas Commission on Environmental Quality (TCEO) to renew Texas Pollutant Discharge Elimination System (TPDES) Permit No. WQ0015352001 (EPA I.D. No. TX0136280) to authorize the discharge of treated wastewater at a volume not to exceed a daily average flow of 20,000 gallons per day. The domestic wastewater treatment facility is located approximately 1700 feet southeast of the intersection of State Highway 35 and Farmto-Market Road 1095, in Matagorda County, Texas 77440. The discharge route is from the plant site to an unnamed tributary of Briar Creek; thence to Briar Creek; thence to Tres Palacios Creek Above Tidal. TCEQ received this application on June 18, 2024. The permit application will be available for viewing and copying at Tidehaven ISD Administration Office, 99 County Road 427 Doman Road, El Maton, in Matagorda County, Texas prior to the date this notice is published in the newspaper. A public meeting is not a contested case hearing. **OPPORTUNITY FOR A CONTESTED CASE HEARING.** After the deadline for submitting public comments, the Executive Director will consider all timely comments and prepare a response to all relevant and material, or significant public comments. **Unless the application is directly referred for a contested case hearing, the response to comments, and the Executive Director's decision on the application, will be mailed to everyone who submitted public comments and to those persons who are on the mailing list for this application. If comments are received, the mailing will also provide instructions for requesting reconsideration of the Executive Director's decision and for requesting a contested case hearing is a legal proceeding similar to a civil trial in state district court.**

Following the close of all applicable comment and request periods, the Executive Director will forward the application and any requests for reconsideration or for a contested case hearing to the TCEQ Commissioners for their consideration at a scheduled Commission meeting.

The Commission may only grant a request for a contested case hearing on issues the requestor submitted in their timely comments that were not subsequently withdrawn. If a hearing is granted, the subject of a hearing will be limited to disputed issues of fact or mixed questions of fact and law relating to relevant and material water quality concerns submitted during the comment period.

## TCEQ may act on an application to renew a permit for discharge of wastewater without providing an opportunity for a contested case hearing if certain criteria are met.
