To Whom It May Concern:

Luminant Generation Company LLC holds Certificate of Adjudication No. 03-4804, as amended ("COA 4804"). Luminant seeks to split COA 4804 into three pieces, with certain rights remaining in COA 4804 and the rest being severed into two new separately designated water rights, referred to below as Water Right A and Water Right B for descriptive purposes. As described in the attached Water Rights Permitting Applications, Luminant requests that the three resulting water rights contain the following authorizations and associated terms and conditions:

- COA 4804 to continue to include:
 - USE: The right to divert and use not to exceed 8,215 acre-feet of water per year from the Sulphur River for industrial, domestic, municipal, agricultural, and recreational purposes within those portions of Red River, Franklin, and Titus counties in the Sulphur River Basin; and
 - Other terms and conditions contained in the current COA 4804, *other than* 1. Impoundment and Special Conditions 5.C. and 5.D. (which should be removed from COA 4804 and only be included in New Water Right A).
- New Water Right A to include:
 - USE: The right to divert and use not to exceed 785 acre-feet of water per year from the Sulphur River for industrial, domestic, municipal, agricultural, and recreational purposes within those portions of Red River, Franklin, and Titus counties in the Sulphur River Basin;
 - IMPOUNDMENT: The right to maintain an existing 7,100 acre-foot capacity off-channel reservoir and impound therein not to exceed 7,100 acre-feet of water. The reservoir is located in the Preston Bland Survey, Abstract 32; the James W. Belue Survey, Abstract 125; the John Courley Survey, Abstract 204; the Randolph Creek Survey, Abstract 218; the Pleasant McMicken Survey, Abstract 581; the L. L. Bigham Survey, Abstract 1057; the John Duval Survey, Abstract 1102; the T. E. Wilson Survey, Abstract 1282; and the T.P.& L. Company Survey, Abstract 1735, Red River County, Texas; and
 - All other terms and conditions contained in the current COA 4804, including all Special Conditions.

- New Water Right B to include:

- USE: The right to divert and use not to exceed 1,000 acre-feet of water per year from the Sulphur River for industrial, domestic, municipal, agricultural, and recreational purposes within those portions of Red River, Franklin, and Titus counties in the Sulphur River Basin; and
- Other terms and conditions contained in the current COA 4804, *other than* 1. Impoundment and Special Conditions 5.C. and 5.D. (which should only be included in New Water Right A above).

By this application, we seek to sever from COA 4804 and combine into one such new, separately designated water right ("New WR B") the following rights:

USE: The right to divert and use not to exceed 1,000 acre-feet of water per year from the Sulphur River for industrial, domestic, municipal, agricultural, and recreational purposes within those portions of Red River, Franklin, and Titus counties in the Sulphur River Basin.

All permit conditions (including the Priority date), except for 1. Impoundment and Special Conditions 5.C. and 5.D. (which we have requested in a parallel application to be severed and combined into a different New WR A) would continue to be included in this New WR B.

Remaining COA 4804 would have a revised volume in 2. Use (8,215 afy) and exclude Special Conditions 5.C and 5.D.



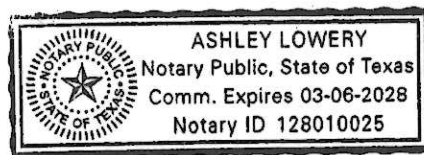
