



Santa Cruz Irrigation District No. 15 (SCID#15) holds the right to divert and use for irrigation purposes 73,744.56 acre-feet of Class A water rights, more or less, per anum under COA No 23-804, as amended. SCID#15 currently has an allocation balance in excess of its projected needs and anticipates that from time to time it will continue to have an allocation balance in advance of its projected needs. In order to maximize the use of its water rights, SCID#15 wishes to add a beneficial use for mining purposes to 5,000 acre feet of its water rights and to lease the water rights during such periods when SCID#15 anticipates having an allocation in excess of its projected needs.

Further, the SCID#15 seeks to acquire authorization to divert the water at any location along the main stem of the Rio Grande between Lake Amistad, as the upper reach, and the Gulf of Mexico, as the lower reach.

This action is not inconsistent with the 2021 Region M Water Plan and the 2022 State Water Plan.



 - 7. Accounting for conveyance losses;
 - 8. Evaporation losses if the water will be stored in or transported through a reservoir. Include changes in evaporation losses and a method for measuring reservoir content resulting from the discharge of additional water into the reservoir;
 - 9. An accounting for spills of other water added to the reservoir; and
 - 10. Calculation of the amount of drawdown resulting from diversion by junior rights or diversions of other water discharged into and then stored in the reservoir.

SUMMARY OF REQUEST

Pursuant to the Texas Water Code and the Commission's Rules and Regulations, Santa Cruz Irrigation District No. 15, of Edinburg, Hidalgo County, Texas, (hereinafter called Applicant), hereby requests the Commission to add a beneficial purpose of use and add global point of diversion of the right to divert up to a maximum of 5,000 acre feet of Class "A" water rights for irrigation from the Rio Grande, hereinafter referred to as the Water Rights, and as grounds for this Application, Applicant would state as follows:

1. The existing purpose of the 5,000 acre-feet of Water Rights of Applicant is for irrigation purposes. Applicant seeks to add mining as a beneficial purpose of use to 5,000 acre-feet of the water rights held under Certificate of Adjudication No. 23-804 and, therefore, a change in purpose of use is requested.

 A. The existing place of use of said Water Rights of Applicant is in Hidalgo County, Texas.

B. Applicant seeks the ability to use the Water Rights within its service area and to also add the right to divert the water rights at any point in Val Verde, Kinney, Marverick, Webb, Zapata, Starr, Hidalgo, Cameron, and Dimmit counties, Texas, along the main stem of the Rio Grande from Amistad Reservoir, as the upper reach, and continuing southward to the Gulf, as the lower reach, with an exempt interbasin transfer for use in those portions of Kinney, Maverick Dimmit, and Webb Counties, Texas within the Nueces – Rio Grande Coastal River Basin.

3. A. The existing diversion point(s) are the existing diversion points of Applicant Santa Cruz Irrigation District No. 15 maintained in association with Certificate of

Adjudication No. 23-804, as amended. The location of these diversion points being well known to the Rio Grande Water Master and described in the Commission records.

B. Applicant seeks to add the authorization to divert the mining rights at any point in Val Verde, Kinney, Marverick, Webb, Zapata, Starr, Hidalgo, Cameron, and Dimmit counties, Texas, along the main stem of the Rio Grande from Amistad Reservoir, as the upper reach, and continuing southward to the Gulf, as the lower reach, with an exempt interbasin transfer for use in those portions of Kinney, Maverick Dimmit, and Webb Counties, Texas within the Nueces – Rio Grande Coastal River Basin.

4. Applicant states that the change in purpose of use, place(s) of use, and point(s) of diversion, as requested herein, does not contemplate an increased consumptive use of water or rate of diversion which would harm any other existing water rights holders on the Rio Grande below Amistad and Falcon Reservoirs; and will not prejudice any other water rights holder on the Rio Grande below Amistad Reservoir.

Section I: Declaration of Policy, Purpose, and Intent

The Board of Directors of the <u>Santa Cruz Irrigation District No. 15</u> deems it to be in the interest of the District to adopt Rules and Regulations governing the equitable and efficient allocation of limited water supplies during times of shortage. These Rules and Regulations constitute the District's drought contingency plan required under Section 11.1272, Texas Water Code, *Vernon's Texas Codes Annotated*, and associated administrative rules of the Texas Commission on Environmental Quality (Title 30, Texas Administrative Code, Chapter 288).

Section II: User Involvement

Opportunity for users of water from the <u>Santa Cruz Irrigation District No. 15</u> was provided by means of <u>posting on webpage</u>, at our <u>District office and via mail outs</u>, as well as monthly meetings that allow for public input on this and any other subject of interest to the respective landowners and district stakeholders. Section III: User Education

The <u>Santa Cruz Irrigation District No. 15</u> will periodically provide water users with information about the Plan, including information about the conditions under which water allocation is to be initiated or terminated and the district's policies and procedures for water allocation. This information will be provided by means of <u>posting on webpage</u>, at our <u>District office and via mail</u> <u>outs</u>, as well as monthly meetings that allow for public input on this and any other subject of interest to landowners and district stakeholders.

Section IV: Authorization

The <u>General Manager</u> is hereby authorized and directed to implement the applicable provision of the Plan upon determination by the Board that such implementation is necessary to ensure the equitable and efficient allocation of limited water supplies during times of shortage.

Section V: Application

The provisions of the Plan shall apply to all persons utilizing water provided by the <u>Santa Cruz</u> <u>Irrigation District No. 15</u>. The term "person" as used in the Plan includes individuals, corporations, partnerships, associations, and all other legal entities.

Section VI: Initiation of Water Allocation

The <u>General Manager</u> shall monitor water supply conditions on a <u>monthly</u> basis and shall make recommendations to the Board regarding irrigation of water allocation. Upon approval of the Board, water allocation will become effective when <u>the combined storage in the Aminstad and</u> Falcon Resevoirs is at or less than 80% of storage capacity for the District water balance.

Section VII: Termination of Water Allocation

The district's water allocation policies will remain in effect until the conditions defined in Section IV of the Plan no longer exist and the Board deems that the need to allocate water no longer exists.

Section VIII: Notice

Notice of the initiation of water allocation will be given by notice posted on the District's public bulletin board and by mail to each <u>account holder for flat rate assessments anda/or active irrigation.</u>

Section IX: Water Allocation

In identifying specific, quantified targets for water allocation to be achieved during periods of water shortages and drought, each irrigation user shall be allocated <u>3</u> irrigations or <u>2.0</u> acre-feet of water each flat rate acre on which all taxes, fees, and charges have been paid. The water allotment in each irrigation account will be expressed in acre-feet of water.
 A specific description and terms of the District Allocation Program are more accurately defined in Appendix A.

- (b) As additional water supplies become available to the District in an amount reasonably sufficient for allocation to the District's irrigation users, the additional water made available to the District will be equally distributed, on a pro rata basis, to those irrigation users having a current account on all payments due the District, and paid a stated yearly deposit for inclusion in the District's allocation program for that year.
- (c) The amount of water charged against a user's water allocation will be <u>8.57 inches</u> per irrigation, or one allocation unit, unless water deliveries to the land are metered. Metered water deliveries will be charges based on actual measured use. In order to maintain parity in charging use against a water allocation between non-

metered and metered deliveries, a loss factor of <u>30</u> percent of the water delivered in a metered situation will be added to the measured use and will be charged against the user's water allocation. Any metered use, with the loss factor applied, that is less than eight (8) inches per acre shall be credited back to the allocation unit and will be available to the user. It shall be a violation of the Rules and Regulations for a water user to use water in excess of the amount of water contained in the user's irrigation account.

(d) Acreage in an irrigation account that has not been irrigated for any reason within the last two (2) consecutive years will be considered inactive and will not be allocated water. Any landowner whose land has not been irrigated within the last two (2) consecutive years, may, upon application to the District expressing intent to irrigate the land, receive future allocations. However, irrigation water allocated shall be applied only upon the acreage to which it was allocated and such water allotment cannot be transferred until there have been two consecutive years of use.

Section X: Transfers of Allotments

(a) A water allocation in an active irrigation account may be transferred within the boundaries of the District from one irrigation account to another. The transfer of water can only be made by the landowner's agent who is authorized in writing to act on behalf of the landowner in the transfer of all or part of the water allocation from the described land of the landowner covered by the irrigation account.

(b) A water allocation may not be transferred to land owned by a landowner outside the District boundaries.

(c) Water from outside the District may be transferred by a landowner for use within the District. The District will divert and deliver the water on the same basis as District water is delivered, except that a <u>60</u> percent conveyance loss will be charged against the amount of water transferred for use in the District as the water is delivered.

Section XI: Penalties

Any person who willfully opens, closes, changes or interferes with any headgate or uses water in violation of these Rules and Regulations, shall be considered in violation of Section 11.0083, Texas Water Code, *Vernon's Texas Codes Annotated*, which provides for punishment by fine of not less than \$10.00 nor more than \$200.00 or by confinement in the county jail for not more than thirty (30) days, or both, for each violation, and these penalties provided by the laws of the State and may by enforced by complaints filed in the appropriate court jurisdiction in <u>Hidalgo</u> County, all in accordance with Section 11.083; and in addition, the District may pursue a civil remedy in the way of damages and/or injunction against the violation of any of the foregoing Rules and Regulations.

Section XII: Severability

It is hereby declared to be the intention of the Board of Directors of the <u>Santa Cruz Irrigation</u> <u>District No. 15</u> that the sections, paragraphs, sentences, clauses, and phrases of this Plan shall be declared unconstitutional by the valid judgment or decree of any court of competent jurisdiction, such unconstitutionality shall not affect any of the remaining phrases, clauses, sentences, paragraphs, and sections of this Plan, since the same would not have been enacted by the Board without the incorporation into this Plan of any such unconstitutional phrase, clause, sentence, paragraph, or section.

Section XIII: Authority

The foregoing rules and regulations are adopted pursuant to and in accordance with Sections 11.039, 11.083, 11.1272; Section 49.004; and Section 58.127-130 of the Texas Water Code, *Vernon's Texas Codes Annotated*.

Section XIV: Effective Date of Plan

The effective date of this Rule shall be five (5) days following the date of Publication hereof and ignorance of the Rules and Regulations is not a defense for a prosecution for enforcement of the violation of the Rules and Regulations.

A RESOLUTION OF THE BOARD OF DIRECTORS OF THE Santa Cruz Irrigation District No. 15 ADOPTING A DROUGHT CONTINGENCY PLAN AND A WATER CONSERVATION PLAN

WHEREAS, the Board recognizes that the amount of water available to the Santa Cruz Irrigation District No. 15 and its water utility customers is limited and subject to depletion during periods of extended drought;

WHEREAS, the Board recognizes that natural limitations due to drought conditions and other acts of God cannot guarantee an uninterrupted water supply for all purposes;

WHEREAS, Section 11.1272 of the Texas Water Code and applicable rules of the Texas Commission on Environmental Quality require all public water supply systems in Texas to prepare a drought contingency plan, and a water conservation plan; and

WHEREAS, as authorized under law, and in the best interests of the customers of the Santa Cruz Irrigation District No. 15, the Board deems it expedient and necessary to establish certain rules and policies for the orderly and efficient management of limited water supplies during drought and other water supply emergencies;

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE _ Santa Cruz Irrigation District No. 15.

SECTION 1. That the Drought Contingency Plan and the Water Conservation Plan attached hereto as Exhibits A and B, respectively, and made part hereof for all purposes be, and the same is hereby, adopted as the official policy of the Santa Cruz Irrigation District No. 15.

SECTION 2. That the General Manager is hereby directed to implement, administer, and enforce the Drought Contingency Plan and adhere to the tenets of the Water Conservation Plan

SECTION 3. That this resolution shall take effect immediately upon its passage.

Friendly Reminder: District Flat Rate Land Assessments are due January 31, and July 31 of each year in semi-annual installments. Prompt payment of the balance due by or before these dates will forego the added expense of penalty and interest assessed on late payments.

Water Delivery:

Flood In-District \$27.50 / Out of District \$33.00; Meter In-District \$55.00 / Out District \$73.00

Flat Rate Assessments: Will increase from \$23.00 per acre to \$26.00/acre

Allocation Program: SCID#15 Board of Directors determined that in order to assure that water allocations are made to persons who intend to use such water a NON-REFUNDABLE DEPOSIT will be required. If you are a current water user and desire to continue to participate in the Temporary Allocation System, then you must pay by 5 P.M on October 31, 2018 a non-refundable deposit of $\frac{13.50 \text{ for each}}{13.50 \text{ for each}}$ acre for which irrigation is desired (even if a deposit had been previously paid on such land), such deposit being a prepayment of water delivery charges, provided that the acreage paid for does not exceed the irrigable acres shown on the flat rate assessment.

Water users must be current on Flat Rate and Special Assessments. District rules prohibit water delivery and allocations when an account is delinquent on assessments or past due for water or other charges. Water allocations will be cancelled after two years of non-use. For further information regarding these rules, please contact Joe Hinojosa, District Manager.

ARTICLE 841 of the PENAL CODE OF TEXAS reads as follows:

"Whoever shall willfully open, close, change, or interfere with headgate or water box withour lawful authority, or who shall willfully use water or conduct water in and through his ditch or upon his land, to which water he was not entitled, shall be fined not less than Ten Dollars and not more than One Thousand Dollars, or be imprisoned in jail not exceeding six months. The possession or use of water to which the person using or possessing same shall not be lawfully entitled shall be prima facie proof of the guilt of the person so using or in possession of same."

Please be advised, the Santa Cruz Irrigation District No. 15 is obligated by its charter to protect District assets and safeguard its water reserves for proper and legitimate use by authorized District land owner entitled to same as outlined by District and State policies and rules thereof. As such, District Staff will use any and all legal remedies to accomplish same to include but not limited to warnings, notice of violation and legal enforcement as described above to fulfill its obligation.
