TNC is working with the TWDB to submit a Water Trust Deposit Agreement, the draft of which is included as an attachment with the application. TNC recognizes the amendment will be subject to the execution of the TWDB Water Trust Deposit Agreement and will file that agreement with TCEQ Staff within 15 days of its execution. In addition, at the time of the execution of the Water Trust Deposit Agreement, TNC will also enter into a Voluntary Management Agreement with Texas Parks and Wildlife Department that outlining TPWD's role in management of the water right during its term in the Water Trust pursuant to Texas Water Code § 15.7031 and Texas Parks and Wildlife Code § 12.028(c).


