ABANDONMENT OF WATER RIGHT

Please note that this action to voluntarily abandon, and the subsequent cancellation of, your water right may not be reversed and obtaining a water right in the future will require a new application for water. 

(d) Permittee is authorized to construct, and before acquiring any right hereunder shall construct, a dam (Dam No. 4) and reservoir on Grapevine Creek and impound therein not to exceed 0.2 acre-feet of water. The dam will be located in the aforesaid Wilson survey. Station 22+85 on the centerline of the dam is N 11° 29' 40" E, 580 feet from the aforesaid Bowen survey corner.

The dams and reservoirs are located approximately 16 miles northwest of Dallas, Dallas County, Texas.

2. USE

Permittee is authorized to use the impounded waters for recreational purposes with no right of diversion from the impoundment.

3. TIME LIMITATIONS

Construction of the dams and related facilities herein authorized shall be in accordance with plans approved by the Executive Director and shall be commenced within 2 years and completed within 3 years from date of issuance of this permit.

4. SPECIAL CONDITIONS

(a) When ordered to do so by the Department, permittee shall provide a means to pass low-flows past the dam in such quantities as may be necessary to satisfy the rights of downstream domestic and livestock users and the senior and superior rights of other authorized users.

(b) Failure to commence and/or complete construction of the dams and related facilities within the period stated in Time Limitations shall cause this permit to expire and become null and void, unless permittee applies for an extension of time to commence and/or complete construction prior to the respective deadlines for commencement and completion, and the application is subsequently granted.

(c) Permittee may impound inflows only when there are flows passing Frasier Dam, authorized pursuant to Certificate of Adjudication No. 08-2457.

This permit is issued subject to all superior and senior water rights in the Trinity River Basin.

Permittee agrees to be bound by the terms, conditions and provisions contained herein and such agreement is a condition precedent to the granting of this permit.

All other matters requested in the application which are not specifically granted by this permit are denied.

This permit is issued subject to the Rules of the Texas Department of Water Resources and to the right of continual supervision of State water resources exercised by the Department.


