Palo Pinto County Municipal Water District No. 1 seeks authorization to extend the time to commence and complete construction of Turkey Peak Dam, located on Palo Pinto Creek, tributary of the Brazos River, Brazos River Basin. More information on the application and how to participate in the permitting process is given below.

APPLICATION. Palo Pinto County Municipal Water District No. 1, P.O. Box 387, Mineral Wells, Texas 76068-0387, Applicant/Owner, has applied to the Texas Commission on Environmental Quality (TCEQ) for an extension of time pursuant to Texas Water Code § 11.145, and TCEQ Rules Title 30 Texas Administrative Code (TAC) §§ 295.1, et seq. Notice is being published and mailed to the water rights holders of record in the Brazos River Basin pursuant to Title 30 TAC § 295.159(a).

Certificate of Adjudication No. 12-4031 authorized Palo Pinto County Municipal Water District No. 1 to maintain Lake Palo Pinto, impounding 44,100 acre-feet of water, on Palo Pinto Creek, tributary of the Brazos River, Brazos River Basin, in ZIP codes 76472, 76453, and 76484.

The Certificate, as amended, authorizes the construction and maintenance of a new dam (Turkey Peak Dam) which increases the storage capacity of Lake Palo Pinto to 49,792 acre-feet of water. Multiple special conditions and time limitations apply.

Applicant has been previously granted two orders to commence and complete the construction of Turkey Peak Dam. The current order issued on May 13, 2020 required commencement of construction of Turkey Peak Dam by October 12, 2021 and completion of construction by October 12, 2024.

Applicant seeks authorization for an additional extension of time to commence construction of Turkey Peak Dam by October 12, 2023 and complete construction by October 12, 2026.

The application and fees were received on October 12, 2021. The application was declared administratively complete and filed with office of the Chief Clerk on November 1, 2021.

The Executive Director has determined that the applicant has shown due diligence and justification for delay. In the event a hearing is held on this application, the Commission shall also consider whether the authorization for the additional storage capacity shall be forfeited for failure to demonstrate sufficient due diligence and justification for delay.

The Executive Director has completed the technical review of the application and prepared a draft Order. The draft Order, if granted, would authorize the extension of time to commence and complete construction of Turkey Peak Dam. A public meeting is intended for the taking of public comment and is not a contested case hearing. A public meeting will be held if the Executive Director determines that there is a significant degree of public interest in the application.

CONTESTED CASE HEARING. The TCEQ may grant a contested case hearing on this application if a written hearing request is filed within 30 days from the date of newspaper publication of this notice. The Executive Director may approve the application unless a written request for a contested case hearing is filed within 30 days after newspaper publication of this notice.

To request a contested case hearing, you must submit the following: (1) your name (or for a group or association, an official representative), mailing address, daytime phone number, and fax number, if any; (2) applicant's name and permit number; (3) the statement "[*I/we*] request a contested case hearing;" (4) a brief and specific description of how you would be affected by the application in a way not common to the general public; and (5) the location and distance of your property relative to the proposed activity. You may also submit proposed conditions for the requested permit which would satisfy your concerns. Requests for a contested case hearing must be submitted in writing to the Office of the Chief Clerk at the address provided in the information section below.

If a hearing request is filed, the Executive Director will not issue the permit and will forward the application and hearing request to the TCEQ Commissioners for their consideration at a scheduled Commission meeting.





"Reasons Why Construction Work Could not be Commenced or Completed"

Under Certificate of Adjudication No. 12-4031A (the "Certificate"), the Palo Pinto County Municipal Water District No. 1 (the "District") is authorized to enlarge Lake Palo Pinto by constructing the new Turkey Peak Dam (the "Project"). The purpose of the Project is to restore and further increase the previously authorized water storage capacity in Lake Palo Pinto by 5,692 acre-feet. The Certificate originally required construction to begin within two (2) years of Certificate issuance and be completed within five (5) years of Certificate issuance. The Texas Commission on Environmental Quality ("TCEQ") has granted the District's prior requests for an extension of time, and the current deadline for commencement of construction on the Project is October 12, 2021, with such construction required to be completed no later than October 12, 2024.

Since the TCEQ's approval of the District's most recent extension request, issued on May 19, 2020, several issues outside of the District's control have temporarily impeded its progress on the Project. Specifically, in addition to the ongoing COVID-19 pandemic and Winter Storm Uri, the District also faced the impending failure of critical infrastructure (which is discussed in more detail below). Nevertheless, it has made significant progress and completed essential steps necessary to commence construction of the Project.

First, the final design of the Project is now nearing completion. Even though pandemic-related shutdowns and precautions prevented the District from effectively and efficiently coordinating with its Project engineer, other consultants, and regulators on the Project's final design, the process to take the final design from 90% to 100% completion is currently underway. The 90% plan set has already been provided to the TCEQ's Dam Safety Program, which returned comments the District is now working to address in the 100% completion set. The District is also on track to complete an updated construction schedule and opinion of probable construction cost by fall 2021.

In addition to the progress on the final design of the Project facilities, the District has remained diligent in its work to complete the land acquisition necessary for the Project. Landowner negotiations, survey work, and title research have remained ongoing since the Certificate's issuance, but COVID-19 and Winter Storm Uri significantly limited the District's ability to complete surveys, inspections, and other critical on-site activities. Nevertheless, only about 15 parcels of land located near or in the inundation area and/or dam site are yet to be purchased by the District, and it has already initiated negotiations to acquire such tracts of land.

Finally, degradation of certain critical infrastructure forced the District to redirect time and money that would have otherwise been available for the Project. Specifically, the District had to reallocate such resources to replace approximately 1,250 linear feet of water pipeline that enables the District to transport water from Lake Palo Pinto to its Hilltop Water Treatment Plant. That pipeline crosses the Brazos River and was at risk of failing due to sustained exposure to river currents, flood events, and debris jams.

Nevertheless, despite the above-described delays, the District has remained diligent in its efforts to begin construction of the Project, not only making the above-described progress but also completing mandatory mitigation work; managing necessary utility relocations; coordinating with other stakeholders, such as the United States Army Corps of Engineers, Palo Pinto County, and the Texas Department of Transportation; and conducting ongoing cultural resources projects in coordination with the Texas Historical Commission. The District appreciates the TCEQ's consideration of this Application and will continue using its best efforts to timely complete this important Project.

AUTHORIZING THE FILING AND PROSECUTION OF AN APPLICATION WITH THE TEXAS COMMISSION ON ENVIRONMENTAL QUALITY FOR AN EXTENSION OF TIME TO COMMENCE AND COMPLETE CONSTRUCTION RELATED TO THE ENLARGEMENT OF LAKE PALO PINTO AND TURKEY PEAK DAM

WHEREAS, Palo Pinto County Municipal Water District No. 1 (the "District") owns Certification of Adjudication ("COA") 12-4031A, issued by the Texas Commission on Environmental Quality ("TCEQ") on October 12, 2015, authorizing the District to enlarge Lake Palo Pinto (so as to restore its authorized capacity) and to construct the new Turkey Peak Dam and Reservoir (the "Project");

WHEREAS, COA 12-4031A includes provisions that require the District to commence construction on the Project within two (2) years of issuance and to complete construction within five (5) years of issuance;

WHEREAS, in 2017, the District filed an application at the TCEQ for an extension of time to commence and complete construction related to the enlargement of Lake Palo Pinto and Turkey Peak Dam ("First Extension Application");

WHEREAS, on February 6, 2018, the TCEQ granted the First Extension Application, setting the deadline to commence construction to October 12, 2019 and the deadline to complete construction to October 12, 2022;

WHEREAS, in 2019, the District filed an application at the TCEQ for a second extension of time to commence and complete construction related to the enlargement of Lake Palo Pinto and Turkey Peak Dam ("Second Extension Application");

WHEREAS, on May 19, 2020, the TCEQ granted the Second Extension Application, setting the deadline to commence construction to October 12, 2021 and the deadline to complete construction to October 12, 2024;

WHEREAS, since the Second Extension Application was approved, the District has continued to move forward with the Project, namely: (i) working with local landowners to obtain the needed real property interests for the implementation of the Project and the District's associated mitigation plan; (ii) performing the final design necessary for the Project; (iii) conducting ongoing cultural resources projects in coordination with the Texas Historical Commission; and (iv) coordinating with other stakeholders, such as the United States Army Corps of Engineers, Palo Pinto County, and the Texas Department of Transportation;

WHEREAS, under Texas Water Code § 11.145 and 30 Texas Administrative Code § 295.184, the District may file and prosecute an application (the "Application") with the Commission requesting an extension of time for beginning construction of a reservoir; and

WHEREAS, the District now desires to file the Application and to authorize its President, on behalf of the District, to prepare and execute such Application to extend the time for commencement of the construction of the Project by two (2) years and completion of the construction by two (2) years.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF PALO PINTO COUNTY MUNICIPAL WATER DISTRICT NO. 1 THAT:

- 1. The recitals set forth above are true and correct and incorporated herein for all purposes.
- 2. The Board of the District hereby authorizes and directs its President to prepare and file the Application and any other documents as are necessary to secure authorization from the TCEQ for an extension of time to commence and complete construction of the Project.
- 3. The Board of the District hereby authorizes and directs Lloyd Gosselink Rochelle & Townsend, P.C., to: (i) prepare and file the Application as well as appear and arrange for the appearances of persons representing the District at hearings and other proceedings on the Application before the TCEQ and other governmental entities; (ii) prosecute the Application on behalf of the District; and (iii) assist the President and Secretary with the preparation and filing of future Applications, if necessary.
- 4. This resolution shall take effect and be in full force and effect from and after the date of its adoption, and it is so resolved that all resolutions of the Board of Directors of the District in conflict herewith are hereby amended or repealed to the extent of such conflict.
- 5. The District's President and/or Secretary, and their delegates are hereby directed and authorized on behalf of the Board of Directors to implement and to take further actions as necessary that are consistent with the purposes of this resolution.
