TCEQ will also evaluate any policy revisions, including Workplace Violence, needed to comply with the notice. The target completion date is the end of FY 2024. <i>HB 915 is complete.</i>
HB	1500	Holland, J	Relating to the continuation and functions of the Public Utility Commission of Texas and the Office of Public Utility Counsel, and the functions of the independent organization certified for the ERCOT power region; increasing an administrative penalty.	1-Sep-2023	TCEQ adopted rules implementing HB 1500. <i>HB 1500 is complete.</i>
HB	1598	Darby, D	Relating to local government and other political subdivision regulation of certain solid waste facilities.	18-Jun-2023	TCEQ improved guidance in accordance with HB 1598. <i>HB 1598 is complete.</i>
HB	1688	Murr, A	Relating to expansion of water quality protection areas.	1-Sep-2023	Revisions to 30 TAC Chapter 311 were adopted in June 2024. Amendment of general permit TXG500000 was issued by the Commission on January 16, 2025. Amendment of general permit TXR050000 to take place December 2023 – June 2025. <i>HB 1688 is complete.</i>
HB	1817	Capriglione, G	Relating to the validity of a contract for which a disclosure of interested parties is required.	9-Jun-2023	TCEQ revised contract templates and procedures to include required changes effective October 31, 2023. <i>HB 1817 is complete.</i>

The rulemaking was adopted and its effective date is March 20, 2025. However, TCEQ started accepting applications for the Provisional licenses on September 1, 2023. All databases have been updated. The bill impacts Wastewater D and Water D licenses. <i>HB 1845 is complete.</i>
HB	2060	Capriglione, G	Relating to the creation of the artificial intelligence advisory council.	13-Jun-2023	TCEQ will submit an automated decisions systems inventory report to the artificial intelligence advisory committee by July 1, 2024. <i>HB 2060 is complete.</i>
HB	2157	Metcalf, W	Relating to the salary of certain employees who transfer within a state agency.	1-Sep-2023	TCEQ will revise the hiring policy and procedures accordingly. The target completion date is September 30, 2023. <i>HB 2157 is complete.</i>
HB	2195	Noble, C	Relating to wrong, fictitious, altered, or obscured license plates.	1-Sep-2023	The vehicle emissions inspection analyzer software required modifications. The project was done concurrently with the analyzer software updates required for HB 3014 (exempting electric vehicles from emissions and exhaust system inspections) and HB 3297 (eliminating mandatory annual vehicle safety inspections for noncommercial vehicles). <i>HB 2195 is complete.</i>
HB	2453	Guillen, R	Relating to the issuance of digital licenses by a licensing agency.	1-Sep-2023	While the bill did not require rulemaking, TCEQ proposed clarifying amendments to 30 TAC Chapter 30, Occupational Licenses and Registrations, to explicitly state that TCEQ may issue a digital license in lieu of a physical paper license. The rulemaking was adopted and its effective date is March 20, 2025. <i>HB 2453 is complete.</i>

HB	2489	Kacal, K	Relating to renaming the Texas Natural Resources Information System as the Texas Geographic Information Office and the duties of certain officers of that entity.	1-Sep-2023	TCEQ will replace the TNRIS name to TGIO within agency communications and on TCEQ's website. <i>HB 2489 is complete.</i>
HB	2518	Bell, K	Relating to public work contracts, including contracts on public property leased to a nongovernmental entity.	1-Sep-2023	TCEQ does not participate in public works contracts. Contracts under HB 2518 will be addressed on a case by case basis. TCEQ does not recognize any necessary changes to agency documentation and processes. <i>HB 2518 is complete.</i>
HB	2815	Jetton, J	Relating to the powers, authorities, duties, and responsibilities of water districts.	18-Jun-2023	Rulemaking proposal for 30 TAC Chapter 293 in Summer 2025 with adoption in Fall 2025.
HB	3013	Slawson, S	Relating to exempting certain contracts from procurement notice requirements.	1-Sep-2023	Texas Procurement and Contract Management Guide (CPA) has been updated. TCEQ did not recognize any necessary changes to agency documentation and processes. <i>HB 3013 is complete.</i>
HB	3014	Harris, C	Relating to the motor vehicle safety inspection of electric vehicles.	1-Sep-2023	The vehicle emissions inspection analyzer software required modifications. HB	3033	Landgraf, B	Relating to attorney general decisions under the public information law.	1-Sep-2023	TCEQ policies and procedures have been updated to reflect new requirements. <i>HB 3033 is complete.</i>

HB	3060	Thompson, E	Relating to the regulation of recycling and recycled products.	27-May-2023	TCEQ adopted rules implementing HB 3060, and created an external Advanced Recycling website listing third-party certification systems for mass balance. <i>HB 3060 is complete.</i>
HB	3130	Guerra, B	Relating to the protection of certain occupational licensing information regarding clients of family violence shelter centers, victims of trafficking shelter centers, and sexual assault programs.	1-Sep-2023	TCEQ needed to update information technology applications so that, when requested under this statute, certain information can be kept confidential. Some of the information individuals may request to be kept confidential has already been publicly withheld for all occupational licensees, effective September 1, 2023, as a result of SB 510. TCEQ has updated the public information requests (PIR) procedures to redact information when requested under HB 3130. <i>HB 3130 is complete.</i>
HB	3232	Rogers, G	Relating to the suspension of an enforcement action against a regional water supply, sewer, or wastewater treatment service for a violation committed by a retail public utility being integrated into the regional service.	1-Sep-2023	<i>No implementation action necessary.</i>
HB	3297	Harris, C	Relating to the elimination of regular mandatory vehicle safety inspections for noncommercial vehicles and the imposition of replacement fees.	1-Jan-2025	The vehicle emissions inspection analyzer software required modifications. The process completed January 1, 2025, effective date of the bill. Additionally, a rule and SIP revision are required to remove references related to safety inspections. The process to complete a rule and SIP revision generally takes 12 to 18 months. The rule and SIP revision to implement HB 3297 were proposed on April 17, 2025 and are expected to be adopted on September 24, 2025. <i>HB 3297 is complete.</i>

In addition, the Leaking Water Wells Account was established. <i>HB 3461 is complete.</i>
HB	3485	Bell, K	Relating to a contractor's or subcontractor's right to elect not to proceed with additional work under a contract.	1-Sep-2023	TCEQ is updating the terms and conditions of agency contracts. The target completion date is December 31, 2023. <i>HB 3485 is complete.</i>
HB	3507	Holland, J	Relating to contracts for the construction, repair, and renovation of certain conservation and reclamation district facilities.	1-Sep-2023	Rulemaking proposal for 30 TAC Chapter 293 in Summer 2025 with adoption in Fall 2025.

HB	4885	Landgraf, B	Relating to the Texas Emissions Reduction Plan.	1-Sep-2023	The bill revised the allocation of administrative costs from \$16 million per fiscal year to not more than 15 percent of TERP Trust revenue each biennium; established the Texas hydrogen infrastructure, vehicle, and equipment (THIVE) grant program; increased the amount that TCEQ may contract with the Energy Systems Laboratory at the Texas A&M Engineering Experiment Station from \$216,000 per fiscal year to \$500,000 per fiscal year and add energy efficiency programs administered by the Public Utility Commission (PUC) or the State Energy Conservation Office (SECO), as well as the implementation of advanced building energy codes, to the types of projects that may be included in the contract; and added downstream “refining” oil and gas activities to projects eligible for the New Technology Implementation Grant Program (NTIG). TCEQ developed THIVE criteria with public input and successfully implemented the program in FY 2024. TCEQ updated NTIG solicitation materias and revised NTIG Guidelines for Grants (RG-484) to incorporate downstream “refining” oil and gas activities in FY 2025. HB 4885 is complete.
HB	4932	Lopez, J	Relating to the amount of foreign emissions of air contaminants in nonattainment areas and the required revision of the state implementation plan to account for those emissions.	1-Sep-2023	TCEQ will estimate the contribution of foreign emissions at federal air quality monitors located in Texas ozone and particulate matter (PM) nonattainment areas, designated as of September 1, 2026. The TCEQ executive director will report to the commission by September 1, 2027, a recommendation on whether to revise the state implementation plan (SIP) to account for the estimated foreign emissions contributions. If a SIP revision is recommended, additional stakeholder outreach, public hearings, and proposal and adoption agendas will be required.
