Public Notice

The executive director of the Texas Natural Resource Conservation Commission (TNRCC or commission) is issuing a public notice of deletion (delisting) of the Hart Creosoting Company from the state registry (state Superfund list) of sites which may constitute an imminent and substantial endangerment to public health and safety or the environment due to a release or threatened release of hazardous substances into the environment.

The site which has been deleted is the Hart Creosoting Company state Superfund site which was originally proposed for listing on the state Superfund registry in the August 19, 1997 issue of the *Texas Register* (22 TexReg 8311-8312). The site is located south of the City of Jasper, Jasper County, Texas, on the west side of State Highway 96, approximately one mile south of U.S. 190.

This notice is issued to finalize the deletion process which began on August 20, 1999, when the executive director of the TNRCC issued a public notice in the *Texas Register* (24 TexReg 6574) of TNRCC's intent to delete the Hart Creosoting site from the state Superfund registry, following the determination made pursuant to the Texas Health and Safety Code, §361.183(d) that the site was now ineligible for listing on the state Superfund registry as it had been accepted under the federal Superfund program on July 22, 1999.

The notice (24 TexReg 6574) further indicated that the TNRCC shall hold a public meeting, as required by 30 TAC §335.344(b), if a written request is filed with the executive director of the TNRCC within 30 days, challenging the determination by the executive director as authorized by the Texas Health and Safety Code, §361.189(a). Equivalent publication of the notice (24 TexReg 6574) was also published in the August 18, 1999 edition of the *Jasper NewsBoy*.

The TNRCC did not receive a request for a public meeting from the potentially responsible parties or any interested persons during the request period (within 30 days of publication of notice); therefore, the Hart Creosoting site is hereby deleted from the Texas state Superfund registry. As the recipient of regional peace officer training funds from the Governor's Office, Criminal Justice Division, Nortex Regional Planning Commission requests information from law enforcement training providers qualified and willing to present courses on site at the Nortex office or other locations, as deemed appropriate, in the Nortex region, including the following counties: Archer, Baylor, Clay, Cottle, Foard, Hardeman, Jack, Montague, Wichita, Wilbarger, and Young. The information provided will be used to compile a Register of Approved Training Providers for our law enforcement training program. Nortex Regional Planning Commission has a current training agreement with Vernon Regional Junior College to report Texas Commission on Law Enforcement Officer Standards and Education credits, therefore providers are not required, but may have, a training agreement or academy license.
