The commission proposes new §11.1, concerning Historically Underutilized Business Certification Program. The new section adopts by reference the rules of the Texas General Services Commission in 1 TAC §§111.11-111.23 (relating to Historically Underutilized Business Certification Program), and establishes guidelines for managing the commission's contracting goals for Historically Underutilized Businesses. This rulemaking is required by the General Appropriations Act (House Bill 1, 74th Legislature, 1995).

Public Notice

The executive director of the Texas Natural Resource Conservation Commission has issued a public notice of a proposed remedial action for a State Superfund Site which constitutes an imminent and substantial endangerment due to a release or threatened release of hazardous substances into the environment.

In accordance with 30 Texas Administrative Code (TAC) §§335.349(a), concerning requirements for the remedial action and the Texas Health and Safety Code, Chapter

361.187 Solid Waste Disposal Act as Amended by Senate Bill 43, Sixth Called Session 1990, concerning the proposed remedial action, a public meeting regarding the proposed remedy for the **Precision Machine and Supply State Superfund Site** must be held at least 45 days after publishing notice of the meeting in the *Texas Register* and in a newspaper of general circulation in the county in which the facility is located. The public meeting is scheduled to be held at the City of Odessa Council Chambers, 411 West Eighth Street, Odessa, Ector County, Texas, on July 16, 1996, at 7 p.m.

Precision Machine and Supply State Superfund Site is located at 500 West Olive Street in Odessa, Ector County, Texas and operated from 1952 until December 1980 as a machine and chrome-plating shop. It was placed on the State Superfund Registry on January 22, 1988. (13 TexReg 427-428).

A remedial investigation was conducted during three phases of investigation between February 1992 and October 1995. The investigation confirmed the presence of contamination at levels which may threaten human health and the environment. A baseline risk assessment concluded that further action was warranted to eliminate potential imminent and substantial endangerment to human health and the environment from the contamination at the site. A feasibility study was prepared that screened and evaluated for the remediation of the site contamination. The Feasibility Study report developed six alternatives for surface soils and subsurface soils, and developed six alternatives for groundwater.

The public meeting will be legislative in nature and not a contested case hearing under the Texas Government Code, Chapter 2001. Persons desiring to make comments on the proposed remedial action may do so at the meeting or in writing prior to the public meeting. All written comments concerning the proposed remedial action selected should be submitted at least ten days prior to the public meeting to Dean Perkins, Project Manager, Superfund Investigation Section, MC 143, Texas Natural Resource Conservation Commission, P.O. Box 13087, Austin, Texas 78711-3087.
