Good afternoon Mr. Geithner,

The TCEQ has received your request for enforcement discretion for a "Groundwater and Fire Protection Upgrade" project at a construction site located at the UT McDonald Observatory at 3640 Dark Sky Dr., Fort Davis, being conducted by AECOM. Specifically, you have requested:

• Enforcement Discretion for monthly inspections as required by 30 TAC 281.25(a)(4) and Part III.F.7.(c).iv. of the General Permit (TXR150000) for small construction sites.

Since you have indicated that the secondary operator and owner, The University of Texas at Austin, will continue conducting monthly inspections, we do not anticipate that enforcement discretion would be needed in this circumstance. The General Permit also requires an inspection 24 hours after the end of a storm event of 0.5 inches or greater. The University of Texas will be required to conduct this required activity if it is needed during this time period. If an unauthorized discharge resulting in environmental harm occurs from unmonitored BMPs, enforcement discretion may be granted on a case-by-case basis. If this occurs, please contact Kent Waggoner, El Paso Region Section Manager at Kent.Waggoner@tceq.texas.gov or (915) 834-4949 to discuss your situation.

The TCEQ remains committed to working with our regulated community on a case by case basis. Regulated entities must maintain records adequate to document activities related to the noncompliance under enforcement discretion, including details of the regulated entity's best efforts to comply.

Please find below and attached the information that you require to grant Enforcement Discretion due to COVID-19 related issued.

AECOM has a project at the UT McDonald Observatory in Fort Davis, TX performing Groundwater and Fire Protection Upgrades. As part of this work, AECOM has prepared a SWPPP to perform piping installation and has been preforming weekly inspections of the erosion control best management practices (BMPs) during construction. Attached, for your reference, is the Small Construction Site Notice.

Because of the COVID-19 issues, work has stopped and all contractors have demobilized from the facility. All BMPs in all place and in good condition and since work has stopped, inspections have been transitioned to monthly instead of weekly. Work is currently scheduled to resume around the beginning of June, but that is subject to change based on future State and County Orders. The Secondary Operator (Owner - University of Texas) has performed concurrent inspections to date with AECOM and will continue to perform monthly inspections of the BMPs.

Because this is generally the driest time of year, BMP's are in good condition, and the Secondary Operator will continue to perform monthly inspections, AECOM requests approval to defer it's inspection until approximately June 5, 2020 when work is expected to resumes at the facility.
