The TCEQ has reviewed your request. Given that the CGA was conducted on February 19, 2020 and that it was conducted incorrectly, BASF TOTAL could have reasonably known that another CGA should have been scheduled before the COVID-19 challenges began in mid-March 2020. In this case, enforcement discretion is not appropriate.

The TCEQ is committed to working cooperatively and reasonably with the regulated community during the COVID-19 pandemic. The decision to disapprove this request will not reflect on any future request that BASF TOTAL may make. Each enforcement discretion request is evaluated based on its own merits.
