Per 40 CFR Part 60 Appendix F and Permit Number 133873, Continental Carbon Company's Sunray carbon black plant (Sunray) is required to operate a continuous emission monitoring system (CEMS) to monitor emissions from its waste gas boiler stack. As part of the requirements to maintain a CEMS, Sunray is required to conduct quarterly cylinder gas audits (CGA). The plant successfully conducted its first CGA in the first quarter of 2020 with the assistance of CEMTEK, the vendor that installed the CEMS.

At this time, Sunray is requesting enforcement discretion from TCEQ to skip the second quarter CGA for the following reasons:

1. The nearby town of Dumas is currently a hotspot for Covid-19 infections

- 2. Sunray requires the assistance of CEMTEK to conduct a CGA
- 3. Sunray has restricted access to the plant to only essential visitors and believes that bringing CEMTEK onsite to conduct a CGA at this time is an unnecessary risk
