Good afternoon, Ms. Carlock:

The TCEQ has evaluated your enforcement discretion request to extend the deadline to submit well completion data for Undine's Demi John Place Water System located in Freeport (Brazoria County), Texas. Based on a review of our records, it appears that the request for Undine to submit this information is related to an investigation originally conducted in March 2019. There are other alleged violations, in addition to the need for well completion data, for which compliance documentation has not been submitted, in violation of requirements found in 30 Texas Administrative Code Chapter 290.

It appears the original request for compliance documentation, and the associated deadlines, occurred prior to any challenges presented by the COVID-19 pandemic. For this reason, the TCEQ is unable to extend enforcement discretion due to COVID-19.

The TCEQ is committed to working cooperatively and reasonably with the regulated community during the COVID-19 pandemic, as appropriate. The decision to disapprove the current request will not reflect on any future request that Undine may make. Each enforcement discretion request is evaluated based on its own merits.
