# From the Office of Compliance and Enforcement

With the onset of COVID-19 (coronavirus) and the Governor's Proclamation of a state of disaster in Texas, the TCEQ is aware that regulated entities may be experiencing an impact from a reduced workforce necessary to maintain normal operations at some facilities. All regulated entities are encouraged to take all available actions necessary to ensure compliance with environmental regulations and permit requirements to protect the health and safety of Texans and the environment. However, in the instance that noncompliance is unavoidable directly due to impact from the coronavirus, an email box has been established by TCEQ to accept requests for potential enforcement discretion. Regulated entities should email both OCE@tceq.texas.gov and Ramiro.Garcia@tceq.texas.gov with specific information related to enforcement discretion requests. The OCE (Office of Compliance & Enforcement) email box is monitored daily by multiple TCEQ staff who will ensure the requests are expeditiously addressed. The TCEQ's goal is to provide a response to the regulated entity's request within 24 to 48 hours.

The email to OCE should at a minimum include the following:

- Concise statement supporting request for enforcement discretion
- Anticipated duration of need for enforcement discretion
- Citation of rule / permit provision for which enforcement discretion is requested

Regulated entities must maintain records adequate to document activities related to the noncompliance under enforcement discretion, including details of the regulated entity's best efforts to comply.

and a response will be provided.



#### Dear Mr. Swiderski:

As we discussed on Monday March 16, 2020, due to the recent world events of the Covid-19 (Coronavirus) pandemic, both the airline industry and Dallas/Fort Worth International Airport are experiencing significant interruption to normal operations. DFW is transitioning to a virtual work environment with all the site staff focused on essential operational tasks and pandemic response. We are currently looking for any way possible to maintain and sustain our current operations.

As an emergency measure, with the TCEQ's approval and agreement, DFW Airport respectfully requests to temporarily change sampling protocols for both the NW Cargo VCP #1461 and the NE Cargo VCP #1460, until the end of DFW's fiscal year (September 2020). Maintaining the integrity of the plumes and ensuring any plume migration stays within DFW Airport's boundaries will still be the number one priority. As such DFW proposes to reduce sampling the number of wells in each area to only sampling perimeter alternate point of exposure (APOE) wells. The reduction will be as follows for NW Cargo, VCP #1461:

#### VCP #1461, NW Cargo, AOC B1

Reduce the number of monitor wells sampled from 94 wells to 12 alternate point of exposure (APOE) wells. Sampling events will include June and September 2020. (See attached map)

### VCP #1461, NW Cargo, AOC B2

Reduce the number of wells sampled from 29 wells to 9 alternate point of exposure (APOE) wells. Sampling event will include April 2020. (See attached map)

VCP #1460 and #1461 March 18, 2020 Page 2 of 2

As we discussed for NE Cargo, VCP #1460, the chlorinated solvent plume has a critical area where the 1,1 DCE plume has migrated to an APOE well. Therefore, for VCP #1461, in lieu of sampling all APOE wells, DFW will sample APOE wells for the chlorinated plume as well as several wells within the footprint of the chlorinated plume. The reduction in wells overall will be as follows:

### VCP #1460, NE Cargo

Reduce the number of wells sampled from 48 wells to 6 alternate point of exposure (APOE) wells and 5 attenuation monitoring point (AMP) wells in the chlorinated plume. Sampling events will include June and September 2020. (See attached map)




NE and NW Cargo VCP #1460 and #1461 File






NE CARGO Monitoringb Well Location Map 2019 PRAC
