Thank you for your call. As discussed, I wanted to provide a written overview of the obstacles that have thus far prevented me from submitting Intertek Automotive Research's (IAR) EI for CY2019.



By 3/23/20 San Antonio and Bexar County had issued their public health order closing non-essential businesses to control the spread of SARS-CoV-2. While IAR was deemed essential and remained open, we were obliged to take numerous additional steps as part of our Infectious Disease Business Continuity Plan. The majority of that coordination fell to the Safety group of which I am a part. Sterilization, remote work, face covering and other protocols all had to be implemented and this took up the vast majority of my time for several weeks.

On 4/13/20 the decision was made that in the face of declining test volume, all salaried staff would be moved to a 50% furlough. Since that time I have only been allowed to work every other week which has drastically reduced my ability to complete large projects like the EI since there is still much safety focused work to be done keeping the site and our employees safe. On 5/14/20 I was informed that the furlough rotations would be extended another four weeks lasting through 6/15/20 assuming business conditions improve along the way.

As I mentioned on the phone, I have never submitted a late EI in my eight years at IAR and it pains me to have fallen short this year. I am not attempting to provide excuses but to explain the externalities that have put me in the current predicament.
