The TCEQ is exercising enforcement discretion on a case-by-case basis for regulated entities that are experiencing operational difficulties and seeking to provide critical services due to the COVID-19 pandemic. Your request is approved. Enforcement discretion will continue no later than October 31, 2020. Please notify the agency of the start date of being over your permitted head count per facility and make notification if it becomes necessary to euthanize livestock and bury onsite. If you have any questions or if new information becomes available, please feel free to contact us at any time.

Please continue to keep us updated as conditions change.

The TCEQ will revisit this issue at the appropriate time and reserves the right to withdraw this approval.
