
We understand TCEQ granted a blanket extension until April 30, 2020 for 2019 emissions inventories, but SI Group hereby requests case-by-case extensions until May 31, 2020 for both the Freeport and Baytown facilities.

SI Group, like most companies, has been adversely impacted by various COVID-19 related issues, including reduced staff and work hours. Accordingly, the individuals responsible to prepare, review, and approve the 2019 inventories have been unable to complete all these tasks prior to April 30, 2020. SI Group is committed to compliance, including the submission of accurate and complete emission inventories, and this request for extension is not for purposes of delay.
