



- \* North of San Jacinto Boulevard and Old Battleground Road
- \* South of IH-10
- \* East of Sheldon Road and Tucker Bayou
- \* West of Independence Parkway and S. Lynchburg Road/Crosby Lynchburg Road/Lynchburg Road

### Why is this Location and Pollutant(s) on the APWL?

Hourly styrene levels in exceedance of the odor Air Monitoring Comparison Value (AMCV) have been reported at the CAMS 1015 Lynchburg Ferry air monitoring site since monitoring began at this location in 2003. The highest number of hourly styrene odor exceedances occurred in 2005, in which there were 92. This number steadily declined in the years 2006 through 2009, with 20 exceedances of the odor-based AMCV in 2009; however, in 2010, the number of styrene odor exceedances increased to 27. The TCEQ continues to encourage reductions of styrene in the Lynchburg Ferry area.
